## WORKSHOPS

### Workshop 1: Working with and providing counselling to vulnerable refugees – taking power into account

*Speaker:* Rafia Shahnaz, GLADT - black and PoC lesbians, gays, bisexuals, Trans\*, Inter\* and queers in Berlin

In this workshop, we invite participants to consider how practical approaches in counselling take the dimension of power into account both on a psychosocial as well as on a therapeutic level. How do we provide support to particularly vulnerable people without reproducing paternalistic and stereotypical prejudices? There will be room to share experiences and learn from each other as well as share best practice examples.

### Workshop 2: InTo Justice: An interdisciplinary approach to assessing the consequences of torture

*Moderator:* Christian Cleusters

In recent years, a model based on the Istanbul Protocol, which relies on an interdisciplinary approach, has been developed in North Rhine-Westphalia to assess the consequences of torture and will be further developed over the next two years. The project combines forensic, therapeutic, social work and legal expertise. Experts will present the model for discussion with participants.

### Workshop 3: Models to identify vulnerability. Good practice and challenges

*Moderators:* Alva Träbert, Rosa Strippe e.V. & Lea Flory, BAfF e.V.

This workshop aims to provide an overview of the models currently being used to identify vulnerable refugees. Representatives of psychosocial and counselling centres from several federal states will present recent projects, their challenges and positive experiences before discussing similarities, strategies and scopes for action.

### Workshop 4: Equal yet different: providing counselling to LGBTI\* refugees

*Moderator:* Falk Wachsmann, Schwulenberatung Berlin gGmbH, Danijela Remer, Schwulenberatung Berlin gGmbH

LGBTI\* refugees have only become more visible in public discourse and in psychosocial centres in recent years. Schwulenberatung Berlin has provided counselling and a number of services to around 2,000 LGBTI\* refugees since 2015. Due to the highly heterogeneous nature of this group of people and their different experiences, needs and desires, both as individuals but also structurally, the abbreviation LGBTI\* (lesbian, gay, bisexual, trans\* and inter\*) cannot cover all gender and sexual minorities. In this workshop, we hope to raise awareness of diversity by offering input, dialogue and best practice examples and examining the particular challenges and opportunities of working with this target group.

### Workshop 5: Psychosocial centres as places of interdisciplinary co-operation – potentials, challenges and limits (translation in English)

*Organised by:* Center ÜBERLEBEN (BNS-vulnerable refugees, outpatient and day unit)

Designed to facilitate exchange between practitioners, this workshop analyses the potentials, but also the challenges in interdisciplinary co-operation in psychosocial centres for refugees. How can effective case management answer the complex psychological, medical, social and not least legal issues facing refugees? How can psychosocial centres contribute through networking across multiple professions and with an interdisciplinary focus based on a holistic approach to counselling, and where are the limits to such an approach? The workshop invites participants to reflect on these questions, but also to share specific best practice examples (i.e. with the aim of sharing knowledge, stances and opportunities).

### Workshop 6: Expanding the lens of vulnerability (in English)

**Due to time zone differences, this workshop will take place between 2 and 4.15p.m.**

*Speaker:* Dr. Erinn Gilson, Merrimack College, USA

This workshop will introduce participants to vulnerability as a complex concept with multiple definitions. It will provide opportunities for participants to reflect on how these ways of understanding vulnerability impact their experiences and work. The session will evaluate the implications of understanding vulnerability as a status (connected to factors such as age, gender, citizenship), a product of socio-political circumstances, and a fundamental part of the human condition, as well as of understanding vulnerability as necessarily harmful or as potentially related to empowerment. The session will focus on exploring the benefits and difficulties of these different understandings of vulnerability, and will pay particular attention to the impact of these ways of understanding vulnerability on those who are labeled “vulnerable”, self-identify as “vulnerable”, and experience different forms of vulnerability.

### Workshop 7: The importance of self-organization- as a tool of resistance. (in English)

*Speaker:* Jennifer Kamau, International Women´s Space

In this workshop, it will be important to build the capacity of the participants to identify and understand the oppressive policies that are common in their context and that which affect them as individuals or collectively. The discussion will provide a deeper insight into the lessons learnt, best practices as well as other relevant strategies that have been applied by similar persons and groups to date in the struggle and fight and to resist. This will also emphasize the need for collaborative and networking efforts with other similar minded persons and groups that are already engaged in the struggles over the years without undermining what has been achieved over time.
